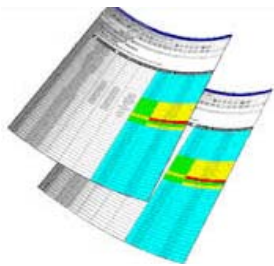


# Annual Environmental Compliance Reporting for Wisconsin Facilities



All industrial facilities need to begin assembling 2014 year end data and preparing for Environmental Compliance Certifications. Reports are DUE in the first part of 2015.

Wisconsin annual environmental compliance reporting dates are as follows:



<b>JANUARY 15, 2015</b>	Periodic Compliance Reports for Industrial Pretreatment Dischargers
<b>JANUARY 30, 2015</b>	Annual Air Permit Monitoring Reports and Compliance Certifications
<b>FEBRUARY 15, 2015</b>	Noncontact Cooling Water Discharge Monitoring Reports
<b>MARCH 1, 2015</b>	SARA Tier 2 Reports (including Fee Statements) AND Annual Hazardous Waste Reports
<b>JUNE 1, 2015</b>	Annual Air Emissions Fee Statements and Compliance Certifications
<b>JULY 1, 2015</b>	SARA Form R Reports
